In order to begin student must be 4 years old September 1st. - Parents must obtain a VPK Voucher from the Early Learning Coalition of Volusia County - The VPK Voucher will only cover the cost of VPK fom 7:30-11:30am - Students must be fully potty-trained

Tuition Rates for Kindergarten through 8th Grade School Year 2026-2027

• New students will have an application fee of \$45 per student, (non-refundable) paid prior to testing. Upon acceptance, the registration fee will be \$375.00. • A parish discount is given up to \$1,000 per family (to be applied only to the tuition) if the family is a St. Peter parishioner and has documentation of donations to the parish by December 31, 2025 of \$500 for the calendar year. Verification of the donation must be made through the church before the discount is given. If you attend a different parish you will only receive a discount if your parish subsidizes. • Students in grades 6-8 are required to purchase a laptop. Specs for the laptops are posted on the school website.

Important Information

FACTS Tuition Management:

All families are required to register for tuition to be paid through FACTS. Information regarding set up with FACTS for the payment of your tuition will be given at time of enrollment/re-enrollment. FACTS assesses a fee (see below) per family/year to cover their management expenses that are separate from the school fees.

1 payment (Paid in Full) = \$20.00

2 payments (June 20th and December 20th) = \$20.00

3 or more monthly installment payments = \$46.00

Grant & Aid application = \$38.00

Returned payment fee \$25.00 ~ CC Service Fee = 2.95%

Tuition Payment Incentive: Families who self pay tuition in full with cash or a check and **(not on any form of Scholarship)** for the entire year by July 31, 2026 will receive a 5% discount.
